I understand that such fee will be used to cover the costs, expenses and incidentals of the Momtrepreneur Fair, with remaining amounts to be donated to a local non-profit organization to be selected by Port Washington Mama.

____ I agree that I am participating at my sole cost, risk and expense and assume sole and complete responsibility and liability for any loss, liability, damage, penalty, claim, cost, expense, theft, judgment or other injury of any kind or nature, real or personal, direct or indirect, which may occur, arise or result, directly or indirectly, in connection with my participation in the Momtrepreneur Fair, and agree to reimburse, indemnify and hold harmless Port Washington Mama, Mommas Pearls, Amanda Khalil, and Cynthia Litman for any such loss, liability, damage, penalty, claim, cost, expense, theft, judgment or other injury of any kind or nature, real or personal, direct or indirect.
